Bridal Hairstyling Contract

AGREEMENT/JURISDICTION

Final Touches and its stylists shall not be held liable for any allergic reactions, injuries, damages, or losses that may occur during or after the hairstyling services. The client acknowledges that they have disclosed any relevant allergies or medical conditions that could affect the hairstyling process.

METHOD OF CANCELLATION/RESCHEDULING

Cancellation of contract must be made in written format via email at least 60 days before the wedding date. The \$100.00 retainer is still nonrefundable. If you cancel 30 days or less prior to your wedding day, a fee of 50% of the total wedding date rate proposal will be charged. If you cancel within 2 weeks of the wedding day, you will be charged 100% of the total wedding date quoted and you will not receive the retainer.

CLIENT RESPONSABILITIES

The client agrees to:

- Arrive at the agreed-upon location and time for the hairstyling services. Attendants who miss their appointment will be taken after all other services have been completed if stylists are still on site and may incur delay fees if services are outside of original booking time. If client misses their appointment 100% if the service amount is due.
- Ensure that hair is clean and dry prior to your service. A \$15.00 blow dry fee will occur if needed
- Provide any hair accessories or extensions to be used in the hairstyling process.
- Disclose any known allergies, sensitivities, or medical conditions that could impact the hairstyling services.
- Cooperate with the hairstylists during the hairstyling process, including following instructions and providing feedback when necessary.

PAYMENTS

The client agrees to make the following payments to Final Touches:

- A non-refundable booking deposit of \$100.00 is required upon signing this contract to secure the wedding date. This deposit will be applied towards the total cost of the hairstyling services. This can be paid by cash or credit card and can be done in person or over the phone.
- Wedding party payments are due at the time of the service. There are NO exceptions, and the payments must be received before leaving the makeup/hair area. Please advise your party of this policy.

TRAVEL

In order to ensure that on-site hairstyling services can be provided smoothly and efficiently, it is necessary for the client to make adequate parking arrangements at the wedding venue. This includes providing sufficient parking spaces for the hairstylists' vehicles. Furthermore, if there are any parking fees associated with the hairstylists' travel to the venue, the client agrees to cover these expenses. In the case of significant travel distance, additional travel fees may apply. Travel within 15 miles of Fargo, ND is \$25.00 per stylist. A mileage fee (\$1.00/mile both ways) will be charged for locations outside of the 15 mile radius of Fargo, ND. Travel fees apply for all pre-event hair/makeup consultations as well as day-of-appointments.

PHOTOGRAPHY

The client grants Final Touches permission to use photographs of the final hairstyling results from the trial and wedding day for marketing and promotional purposes, including but not limited to the company's website, social media, and printed materials. We may also contact the photographer and/or videographer for professional images and video footage.

WEATHER OR FORCE MAJEURE

- In the event of extreme weather conditions or force majeure circumstances that prevent the hairstyling services from taking place as scheduled, Final Touches will make reasonable efforts to accommodate an alternative date or time.
- If an alternative arrangement cannot be reached, the liability of Final Touches is limited to the refund of the deposit or fees paid for the affected services.

HAIR AND MAKE-UP TRIAL

Although it is not required, we highly recommend you do a hair/makeup trial 30 days or less prior to your wedding day.

Bridal Hairstyling Contract

EARLY CALL TIME

A \$50 per hour fee will be charged for appointments starting before 8:00AM

HOLIDAY/HOLIDAY WEEKENDS/SUNDAYS

An additional \$100 (per artist) will be added to the final billing for holiday and/or holiday weekend, and or Sunday weddings.

BEHAVIOR CLAUSE

Final Touches and/or any and all of its employees reserves the right to cancel your agreement at any time for overly rude, or obnoxious behavior from anyone in the wedding party, family members, and guests. Any comments thought to be overly rude or obnoxious behavior will merit a warning, any further comments will result in the termination of services at no expense of Final Touches Salon. In this case, clients will be required to pay any/all expenses occurred.

CHANGES TO SERVICES

- You may add people up to 30 days before the wedding date, if time allows and this must be approved by Final Touches. You may subtract people up to 60 days prior to the wedding date. If there are any subtractions of services within 30 days prior to the wedding date, there is a fee of 50% of the service costs that are due. If any subtractions are made within 2 weeks or less of the wedding date, 100% of the service costs are due.
- Changes requested after this deadline may be subject to additional fees or may not be accommodated due to scheduling constraints.

CLIENT APPROVAL

The client must give their approval for the completed hairstyle before the hairstylists leave the premises. Once the client has approved the hairstyle and the hairstylists have left the premises, any further adjustments or modifications requested will be subject to additional fees.

SERVICE LOCATION AND REQUIREMENTS

Location of services for the day of the event will be at the discretion of the client, however, there are certain requirements the makeup artist and hair stylist need for accommodation. A "set up" work area needs to be made available for both the makeup artist and hair stylist at said location. Ample lighting, preferably by means of natural light (such as by a window) or lamps are necessary for services to be performed properly. Please have counters cleaned prior to arrival in designated areas. Hair Stylist will need a low back chair (can be requested prior with hotel upon initial reservations if not already in room) and access to electrical outlets. Hair stylist will bring extension cord as well. If possible, it's best to have hair stylists and makeup artists in separate areas due to aerosol sprays in the air during makeup applications.

FINAL TOUCHES SALON EQUIPMENT/TOOLS/PRODUCTS

All products, tools, equipment, that Final Touches Salon brings are only to be used by Final Touches Salon staff.

GRATUITY

For parties of 5 or more, a 20% gratuity will automatically be added on for all services.

Cancellation of contract must be made in written format via email at least 60 days before the wedding date. The \$100 retainer is still non-refundable if you cancel. If you cancel 30 days prior to your wedding date, a fee of 50% of the total wedding date rate quote will be charged. If you cancel within 2 weeks or less of the wedding date, you will be charged a fee of 100% of the total wedding day rate quoted and will not receive the retainer or final payment.

\$695 (GRATUITY INCLUDED)

Up to FOUR guests of the groom- groom included. Scheduled appointments for haircuts and beard trims a week prior to other event. Event Day- up to two hours of touch-ups, a light makeup application, "Goody Bag" of styling products, & up to 4 hours reserved area in the bar lounge where craft sodas, beer, and wine are served.

THE MANBOOSHIE GROOMSMEN.

\$995 (GRATUITY INCLUDED)

Up to SIX guests of the groom- groom included. Scheduled appointments for haircuts and beard trims a week prior to other event. Event Day- up to three hours of touch-ups, a light or full makeup application, "Goody Bag" of full size styling products, & up to 4 hours reserved area in the bar lounge where craft sodas, beer, and wine are served.

Important Information for Your Bridal Services

TO HELP US SERVE YOU BETTER AND ENSURE THAT YOUR WEDDING DAY RUNS SMOOTHLY, WE ASK THAT YOU AND YOUR WEDDING PARTY PLEASE FOLLOW THESE SIMPLE GUIDELINES:

Please arrive with clean, dry hair to help the hold of your hairstyle. An additional fee will be applied if you need your hair dried with a blow dryer and could cause delays.

Make sure your face is clean and moisturized prior to your makeup application with the make up artist.

For your trial run and day of wedding, please bring in your headpiece, veil, and any hair accessories to try on. We always recommend bringing pictures of makeup and different hairstyles that you are interested in for the makeup and hairstylist.

Any haircutting or coloring should be done 1-2 weeks before the wedding.

Do not change skincare or makeup routine within 2 weeks of wedding. Reactions can occur when trying new products and you want your skin to look and feel flawless for your wedding.

The day before your wedding, shampoo and blow dry your hair with minimal product.

On the day of your wedding, you are invited to bring in any drinks or food that you feel will make your day more special. We do offer complimentary tea, coffee, and water, but you may feel free to bring in a more personalized selection.

Wearing a zip up sweatshirt will ensure nothing has to be lifted over the face or head that could potentially mess the hairstyle or makeup application.
