**Terms & Conditions** 

Booking/Deposit: To secure a date and schedule services for makeup and/or hair, a signed contract is required as well as a nonrefundable \$100

retainer on the date of signing. The retainer payment can be paid by cash, check (written to Final Touches Salon), or credit card. This can be

done in person or over the phone.

Cancelation Policy: Cancellation of contract must be made in written format via email at least 60 days before the wedding date. The \$100

retainer is still nonrefundable. If you cancel 30 days or less prior to your wedding day, a fee of 50% of the total wedding date rate quote will be

charged. If you cancel within 2 weeks or less of the wedding day, you will be charged a fee of 100% of the total wedding day rate quoted and

you will not receive the retainer or final payment

Contracted Services Per Person: You may add people up to 4 weeks before the wedding date, if time allows & this must be approved by Final

Touches Salon. You may subtract people up to 60 days prior to wedding date. If there are any subtractions of services within 30 days prior to

wedding date, there is a fee of 50% of the service costs that are due. If any subtractions are made within 2 weeks or less of the wedding date, a

fee of 100% of the service costs are due.

Payment: Payments can be made via cash or credit card. If the wedding is less than two weeks away at time of booking, 100% of the payment is

due. Wedding party payments are due at the time of service. There are no exceptions, and the payments must be received before leaving the

makeup/hair area. Please advise your party of this policy.

Early Call Time: A \$50 per hour fee will be charged for appointments before 8:00am CST.

Holiday/Holiday Weekends/Sundays: An additional \$100 (per artist) will be added to final billing for holiday and/or holiday weekend (if holiday

falls during the week), and/or Sunday weddings.

Hair/Makeup Trial: Although it is not required, we highly recommend you do a hair/makeup trial 30 days prior to your wedding day.

Service Location and Requirements: Location of service(s) for the day of event will be at the discretion of the client, however, there are certain

requirements the makeup artist and hair stylist need for accommodation. A "set up" work area needs to be made available for both the makeup

artist and hair stylist at said location. Ample lighting, preferably by means of natural light (such as a window) or lamps are necessary for services

to be performed properly. Please have counters cleaned prior to arrival in designated areas. Hair stylist will need a low back chair (can be

requested prior with hotel upon initial reservations if not already in room) and access to electrical outlets. Hair stylist will bring extension cord

as well. If possible, it's best to have hair stylists and makeup artists in separate areas due to aerosol sprays in air during makeup application.

Timing: Attendants who miss their appointment will be taken after all other services have been completed if stylists are still on site and may

incur delay fees if services are outside original booking time. If Attendant misses their appointment, a fee of 100% of the service amount is due.

Final Touches Salon 1665 43rd St S Suite 101 | Fargo, ND 58103 **Delays:** In the event scheduled services exceed the allotted time due to client delays, the stylist will make every effort to accommodate the bridal party. Final Touches has full discretion, based on availability, whether to continue services past the scheduled end time. Incompletion of

services based on a client delay does not warranty a refund or discount on the final amount due.

Additional Services: If time allows, anyone not listed on the initial bridal contract may be accommodated for makeup and/or hair. Payment is

due at the time of services by cash or credit card.

Limitation On Liability: Client holds the stylist harmless for any claim, loss, damage, or injury to any person or property arising, either directly or

indirectly, from the artist's performance.

Wet Hair: If a Final Touches stylist has to use a blow dryer on a clients hair, a \$15 fee will be applied to each client that the blow dryer is used

on.

Touch Up Kit: The bride will be provided with a touch up kit. This will include lip product used, mascara wand, lip applicator, bobby pins, blotting

sheets, makeup remover wipes, and hand sanitizer towel. Touch up kits are not provided to the rest of the bridal party. If they have a lip product

they would like their makeup artist to use, so they can touch up throughout the day, please feel free to let your makeup artist know.

Liability: All brushes, hair, and makeup products are kept sanitary. Any skin conditions or sensitivities should be reported by the client to the

stylist/makeup artist prior to application and, if need be, a sample test of makeup may be performed on the skin to test reaction. Client(s)

agrees to release the makeup artist/hair stylist, if applicable from liability for any skin complications due to allergic reactions. Clients with

extreme sensitivities may prefer to use their own skincare and/or cosmetics to prevent complications.

Force Majeure: If performance of this contract or any obligation under this contract is prevented, restricted, or interfered with by causes beyond

either party's reasonable control ("Force Majeure"), and if the party is unable to carry out its obligations, gives the other party prompt notice of

such event, then the obligations of the party invoking this provision shall be suspended to the extent necessary by such event. The term Force

Majeure shall include, without limitation, acts of God, fire, explosion, vandalism, storm, or other similar occurrence, orders of acts of military or

civil authority, or by national emergencies, insurrections, riots, or wars. The excused party shall use reasonable efforts under the circumstance

to avoid or remove such causes of non-performance and shall proceed to perform with reasonable dispatch whenever such causes are removed

or ceased.

Privacy: Final Touches and its employees take the client's privacy seriously and will not divulge or discuss any details regarding your booking or

your personal details with anyone not directly connected with your booking. All details collected are for the sole purpose of providing the best

possible service to the client.

Behavior Clause: Final Touches and/or any and all of its employees reserves the right to cancel your agreement at any time for overly rude, or

obnoxious behavior from anyone in the wedding party including bride, groom, bridesmaids/attendants, mother/father of bride/groom, family

members and guests. Any comment thought to be overly rude or obnoxious behavior will merit a warning, any further comments will result in

the termination of services at no expense of Final Touches Salon, and/or any of its employees. In this case, clients will be required to pay any/all

expenses accrued.

Non Disparagement: We support freedom of speech, however, will not tolerate false or disparaging comments posted by any client on any web

or social media site, message boards, or via internet including Facebook, Wedding Wire, & The Knot, etc., This will result in court proceedings to

recover any damages to Final Touches Salon. Client will also be responsible for all attorney fees.

**Parking Fees**: Where parking, valet, or toll fees may be incurred. This amount will be included in the final bill and will be due on the day of the event. This fee is the responsibility of the client.

**Travel Fees**: Travel within 15 miles of Fargo, ND is \$25. A mileage fee (\$1.00/mile both ways) will be charged for locations outside of the 15-mile radius of Fargo, ND (58103). Travel fees apply for all pre-event hair/makeup consultations as well as day-of appointments.

Social Media & Website: Photos taken at the trial, or your professional photos may be used as examples of our work for future clients to view. Your photographer will receive proper credit for their work. You agree to Final Touches Salon using these photos, as well as give consent to using your professional photos on our website/portfolio/social media. We will email you to request these photos and will also reach out to your photographer.

Gratuity: For parties 5 and over, a 20% gratuity will automatically be added on for all services.

WiFi Password: For on-site services, we require the venue password to ensure we're able to use our software for payments.

As part of our Wedding Contract, Final Touches Salon requires credit card information & a \$100 non-refundable retainer to reserve a wedding date. Cancellation of contract must be made in written format via email at least 60 days before the wedding date. The \$100 retainer is still non-refundable if you do cancel. If you cancel 30 days prior to your wedding date, a fee of 50% of the total wedding date rate quote will be charged. If you cancel within 2 weeks or less of the wedding date, you will be charged a fee of 100% of the total wedding day rate quoted and will not receive the retainer or final payment.

## Important information for your Bridal Services

To help us serve you better and ensure that your wedding day runs smoothly, we ask that you and your wedding party please follow these simple guidelines:

Please arrive with clean, dry hair to help the hold of your hairstyle. An additional fee will be applied if you need your hair dried with a blow dryer and could cause delays.

Make sure your face is clean and moisturized prior to your makeup application with the makeup artist.

For your trial run and day of wedding, please bring in your headpiece, veil, and any hair accessories to try on. We always recommend bringing pictures of makeup and different hairstyles that you are interested in for the makeup artist and hairstylist.

Any haircutting or coloring should be done 1-2 weeks before the wedding.

Do not change skincare or makeup routine within 2 weeks of wedding. Reactions can occur when trying new products and you want your skin to look and feel flawless for your wedding.

The day before the wedding, shampoo and blow dry your hair with minimal product.

On the day of your wedding, you are invited to bring in any drinks or food that you feel will make your day more special. We do offer complimentary tea, coffee, and water, but you may feel free to bring in a more personalized selection.

Wearing a zip up sweatshirt will ensure nothing has to be lifted over the face or head that could potentially mess the hairstyle or makeup application.
